Introduction

This report provides a more detailed analysis of the responses to the questionnaire run in July 2022.

302 questionnaires were completed with 2313 free form comments.

This report includes the quantitative results and the qualitative feedback expressed in the free form comments.

All the comments were reviewed and categorised into classes that most suited the question. The comments analysis had the objectives of gaining an overall impression of the key themes for the NewNP, to inform the working groups and to identify key topics that were not directly addressed by the questions.

This analysis groups the questions into sets representing a wider theme. These are

- On overview of the current NDP and suggested changes and additions including opinion on the current Vision statement and possible developments over the next 15 years.
- An analysis of homes and housing requirements.
- Feedback on roads, cycling, pedestrian safety, parking and public transport
- Climate change specifically renewable energy generation
- Facilities (medical, shops, schools)
- Design

The following two questions were each dealt with as separate sections.

11. Would you like to see more publicly accessible open space in the Parish? (qu. 31) 12. Would you like to see the centre of the village and its facilities enhanced? (qu. 33)

The analysis categorised comments under a number of headings reflecting the possible key themes of the NewNP:

- Vision
- Climate Change (community generation, residential/public buildings, mitigation)
- Housing/homes
- Highways and transport (road, cycling and pedestrian safety, parking, public transport.
- Facilities (medical, shops, schools, cafes, community halls, sports facilities).
- Design guides and codes (buildings, public spaces)
- Environments (biodiversity, green spaces, street environment)
- Other

Also recorded were 'General' comments that were not specific in nature, more of an observation

Profile of Respondents

1. How long have you lived in the Parish?

The were 302 responses.

Two respondents have lived in the Parish over 50 years and one respondent noted their business had been in the Parish over 50 years.

2. Which age group do you fall in?

There were 296 responses

- The younger demographic was significantly under represented (see table below).
- Conversely the older age groups were over represented.

New Neighbourhood Plan (NewNP) Overview

This section of the report covers the responses to questions which consider the totality of the NewNP giving an overview of what is valued or should be considered for change. The responses direct the choice of the principal themes to be addressed in Stage 2 of the development of the Plan.

Included are

Section 3 (questions 3a, 3b, 3c) that cover opinions on the current Vision and Neighbourhood Development Plan

Sections 4, 5, 6 and 7 (questions 6-11) that cover what is liked about living in the parish and what needs improvement or new/additional facilities.

Section 15 (Qu 40) seeking any further suggestions on how the parish could develop in the period to 2037.

3a. What is your view of the existing Neighbourhood Plan (NP): what was good; what was not so good?

There were 221 responses to this question. These were categorised as 'Good', 'Not so Good' or 'Neutral'. The 'Good' and 'Not so Good' were as follows.

The most common 'Not so Good' comments were about

- The 1ha of reserved land and the non-delivery of the school and doctors' surgery.
- Not enough affordable and 'downsizing' homes.
- Lack of implementation progress.

3b. What do you think of the 'Vision' of the current NP - is it still up to date or do you think it needs to be revised for the future NP

54% of respondents think It should be altered for the future NP, 46% of respondents It should remain unchanged

3c. What other topics should be considered?

The top themes for inclusion in the NewNP from 261 respondents.

4. What do you like about living in the Parish?

Total number of responses: 261

- 60.3% (143 responses) selected 'Living close to the country side' as their first choice.
- The next first choice was 'The local facilities' with 12.3% (28 responses).
- If respondents first and second choices were combined 'Living close to the countryside' was still overwhelmingly the top choice.

The free comments identified having family close by as a top reason.

5. When thinking about living in the Parish, do you feel that the following need improvement

There were 261 responses to this question. The top priorities for improvement were

- Parking around the schools 184 responses (71.6%)
- Health facilities 127 (50.0%)
- Bus links 88 (34.5%)
- The local facilities (shops, pubs, village hall etc) m- 81 (31.3%)

7. What do you think could be improved about living in the Parish?

There were 262 responses.

The top priorities (first and second preferences combined - number of responses) were

- Enhance medical and social services 79
- More parking around the schools 60
- A community energy plan to help generate energy sustainably and economically on a community scale – 56
- Enhance local facilities (shops, public houses, etc) 53

There were 169 comments with two dominant comments

- Housing for the elderly 42
- Traffic congestion and speed 41

Many of these were accompanied by the comment that these options were not on the online questionnaire.

15. Do you have any other thoughts or comments about what you would like to see happen in the Parish over the next 15 years

Only 6 respondents (3.3%) felt they had other thoughts about what should happen and 54 (29.7%) responded they had nothing to add. However, 106 comments were entered.

The main subjects were

- Vision for Mortimer 23: the majority were about maintaining the current parish ethos and character; a few expressed the view that the parish needs to accept change.
- Facilities 26: the top topics concdned medical facilities, facilities for the younger demographic
- Highways and Transport 20: 7 of the 20 comments expressed concern about traffic speed/volume
- Environment 15: the comments were a mixed bag with no significant theme
- Homes 13: 6 of the comments concerned need for more homes for the over 55s.
- Sustainability and Climate Change 8

Housing

This section covers the types of homes the community considers are necessary. The design of homes including residential power generation, water harvesting, sustainable materials are covered in the section Design Codes.

Responses to Questions 8a-d and 9a-d are covered.

There were 124 comments of which the principal ones were

- Overall design and general design considerations 45 responses
- Climate change requirements should be a prerequisite 29 responses
- Favoured current designs 15 responses
- Vision of future 6 responses

There were some specific comments that were totally prescriptive e.g. no planning permission should be granted for extensions worth 30k+ without installation of solar panels.

14a. Would you support the use of high quality and sustainable materials if this the meant that property prices increased to cover these costs.

Out of the 136 responses 52.2% were in favour, 19.9%would not support the proposition (27.9% responded n/a).

The 112 comments were split as follows

- 41 noted the question did not appear on the paper questionnaire
- 36 referred to the cost implications; of these
 - 12 responded the cost of subsequent maintenance would be lower offsetting the initial higher cost /would be willing to pay the higher cost,.
 - 8 thought the homes were already too expensive,
 - o other comments referred to need to protect cost of affordable homes and that market forces would dictate.
- 15 comments were of a general nature regarding use of sustainable material
- 8 comments related to a variety of climate change considerations.
